
The City has received a sign design for Min's Asian Massage at 793 Plum.

The request includes adding this business sign to the existing multiple-tenant pole sign and adding window signage for this business. The existing pole sign is internally lit, and when a last new tenant install their sign (Dez tactical arms), it was agreed that consistency on the sign was most important. Therefore, the back lighting or the white background was accepted.

The window signage is less than 25% of the door pane itself (lettering only ~11%, box around ~20%).
